Resolution 2026-_____Weiss and Winter Library Support—Mr. Markgren presented the need for a resolution setting funding for the libraries. The resolution sets funding for Weiss and Winter libraries at the greater of 150% of the Wisconsin Act 150 circulation support formula amount or 102.5% of the previous year’s County allocation, and is supported by members and boards of both libraries and was approved by the Economic Development and UW Extension committee.
